in Class 37, that is to say: Building construction; repair; installation services; service, maintenance and repair of: earth moving, earth conditioning, material handling, construction, mining, paving, agricultural, oil and gas exploration, demolition, scrap, waste, landscaping, and forestry vehicles, equipment, and machinery, engines, and power generation equipment, and control units for the aforementioned; machinery installation, maintenance, and repair; rental of earth moving, earth conditioning, material handling, construction, mining, paving, agricultural, oil and gas exploration, demolition, scrap, waste, landscaping, and forestry vehicles, equipment, and machinery, and power generation equipment; remanufacturing of engines, transmissions, power train components, power generation units, land vehicles, earth moving and conditioning machinery, material handling machinery, agricultural machinery, paving and construction equipment, electronic components of the foregoing, and consumer electronics.

The applicant claims colour as a distinctive feature of the mark: yellow & black.
